3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. The programs have been granted accreditation for further 3 years. SIES Graduate School of Technology, Plot No. 1 C/D/E, Sri Chandrasekarendra Sarawathy Vidyapuram, SECTOR-5, Nerul, Navi Mumbai, Maharashtra - 400706 should submit fresh online application under SAR Tier-II June 2015 Document through eNBA portal at least five months before the expiry of validity of accreditation mentioned above.

The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to SIES Graduate School of Technology, Plot No. 1 C/D/E, Sri Chandrasekarendra Sarawathy Vidyapuram, SECTOR-5, Nerul, Navi Mumbai, Maharashtra – 400706 as a whole.
