FAQs for FE Admission 2020-21

1. What are the eligibility criteria for admission?

Passed HSC or its equivalent examination with Physics and Mathematics as compulsory subjects along with one of the Chemistry or Biotechnology or Biology or Technical or Vocational subjects, and obtained at least 50% marks (at least 45% marks, in case of Backward class categories and Persons with Disability candidates belonging to Maharashtra State only). Further, the candidate is also required to have a valid score in MHT – CET / JEE (Main) for that Year.

2. What are the documents required for admission?

A Student applying for admission should carry the original and 2 sets of photocopies of all his testimonials. The documents required are:

- 1. Adhaar Card
- 2. 10th Marksheet
- 3. 12th Marksheet
- 4. Proof of Entrance Exam
- 5. Three passport size photographs
- 6. Proof of Gap years (if any)
- 7. Domicile certificate/Birth certificate/Leaving Certificate with place of birth
- 8. Minority Language certificate applicable to Minority Category students

3. What are the important dates related to admission?

4. How to apply? What is the application procedure?

The application process for engineering admission is conducted by State Common Entrance Test Cell, Govt. of Maharashtra. It is **MANDATORY** for the candidate to **REGISTER and ENROL** on the website for becoming part of the Central Admission Process(CAP).

5. What is the DTE code of SIES Graduate School of Technology?

6. Can students from other states of India take admission through Centralized Admission Process (CAP)?

7. What was the cut off percentage of your college for the last year?

8. I would like to take admission through management quota. Is it still mandatory to register on Directorate of technical education web portal?

YES. Registration and Enrolment on the web portal of State Common Entrance Test Cell, Govt. of Maharashtra is MANDATORY.

9. What is the procedure of admission for Institute / Management seats?

Admission through institute / management quota in SIES is purely on Merit basis. All the candidates applying under quota will be eligible for participating in admission process. But registration with DTE is mandatory. Students who wish to apply for the same should contact the institute and apply directly at the Institute after enrolling at web portal of MHTCET Cell. A separate merit list will be prepared and displayed and the candidates will be called for counselling round/s as per the DTE/MHTCET Cell guidelines.

10. If I apply for Institute / Management seat, is my admission confirmed?

Ans. NO. Merely applying doesn't ensure admission in the institute. Admission depends on the merit list and guidelines specified by the institute. All the information regarding admission will be updated in the college website from time to time.

11. What is the fee structure of the college?

Ans. The fee is as prescribed by the Fee regulatory Authority and the same will be notified on the institute website.

12. What kind of infrastructure is available in the college?

Lush Green Campus, Eco-Smart Classroom with round the clock accessible WI-FI, well equipped class rooms, adequate library facility with online resource and ease of access facility using Digital Library, State of the Art Labs, Air conditioned Auditorium, Seminar hall, Computer Centre, Language Lab etc. Also Bank Facility, Stationery Shop, Student Recreation Area, ideal Campus Security with CCTV and state of the art Gym Facility are available in the campus

13. Do you have hostel facility?

NO, But college provides information about hostel /separate room facilities in the vicinity.

14. Can we get Category Concession/scholarship/free ship in fees?

Category concession is applicable ONLY to the candidates who have secured admission through CAP and belonging to Maharashtra. Concession is applicable as per the government resolution/ directives issued by competent authorities from time to time.

15. Can I Apply for Two Scholarships at a time such as SC/ST/NT/VJ/SBC/OBC, Minority, TFWS?

NO. At any given point of time, you are eligible to apply for any ONE of the scholarship schemes as discussed above. If found violating this, serious action can be initiated against the candidate / student.

16. What is TFWS seat?

It is Tuition Fee Waiver Scheme by AICTE/Government of Maharashtra for meritorious students from the State of Maharashtra and having their parents annual income below 6.00 Lacs. These seats shall be filled by the competent authorities.

17. How are the Campus Placements? Which companies do visit the campus for placements? What is average salary drawn?

Very GOOD, SIES GST has an exclusive Training and Placement Cell continuously engaged in the training and placement activities round the year. The institute ensures all the eligible candidates are placed in reputed companies. A good number of companies visit the campus every year.

20. Does the Institute provides internship?

21. What is difference between B.E. and B.Tech.?

There is no academic difference between B.E. in Bachelor of Engineering & B. Tech. in Bachelor of Technology. Colleges those who are affiliated with the Universities offer B.E. Degree and the autonomous and private universities offer B.Tech. Degree.

22. Can we change the branch at second year level?

YES. But it depends upon the vacancy position in the branch of your choice. Additionally you must fulfil all the conditions/ rules laid down by the competent authorities. The branch/course change will be considered based on merit of First Year Engineering result/s.

23. How does the college admit students?

Two ways:

- 1. Seats allotted by DTE through online CAP process
- 2. Institute Level /Management quota through merit basis prepared by the institute.

24. What are college timings? Is Saturday working?

College timings are 9 am to 5 pm. Non-academic activities are conducted on Saturdays. All faculty members are available in the campus for the doubt solving sessions.

25. Does my ward need to join tuition classes?

Please do not enrol your ward for any tuitions outside. Our faculty members are very experienced to provide extra guidance to students. Special sessions/remedial classes are regularly conducted for the weak learners after college hours/saturdays.

26. Does Tuition Fees remain same till the completion of the Course?

YES. However, the guidelines will be followed as prescribed by the concerned authority (Fee Regulatory Authority) from time to time.

27. Is it Mandatory To Pay Tuition Fees In One Instalment Only Every Year?

YES, however, it can be paid in instalments with special permission and subject to norms and conditions laid down by the Management.

28. Is It Mandatory To Submit All Required Document In Original?

Yes. Your admission is confirmed only when you pay the fees as applicable and submit all the required documents in original.

29. How far is the Institute from Nerul station?

Campus is approximately 2 kms away from the Nerul station. Shared autos are available between the institute and station.

30. Is the Institute NAAC/NBA accredited?

Yes. The institute is NAAC accredited . Applied for NBA accreditation and awaiting peer team visit.

31. Can I get guidance for Admissions?

32. Is canteen facility available in campus?

No, you need to apply only after the results of Class XII and CET/JEE are declared.

Yes, documents for Bank Loans will be issued after the confirmation of admission

42 How to obtain minority status confirmation certificate?

A format will be provided (Form O) in the DTE/CET Cell Information Brochure and the duly filled format to be submitted at the time of form submission. However, the duly filled format to be submitted in Rs.100/- stamp paper and duly notarised.

43 What is the meaning of Minority Institution?

Minority Institution" means seats earmarked for the Minority Community students from within the State, belonging to the Minority Community either Linguistic (based on the mother tongue) or Religious to which the institution belongs. Our institute belongs to Tamil - Linguistic Minority category. This provision is made as per the Constitution of India.

44 My father is Tamil minority and mother is non-Tamil, can I apply under Minority category

No, minority status is based on mother tongue, therefore mother should be Tamil Minority. Father's Minority status is not considered

45 Can I get admission in SIESGST though I do not belong to Minority category?

You can apply as Open candidate through Centralised Admission Process(Conducted by the Maharashtra State CET Cell) or under Management Quota through the respective institute.
