

Guidelines for Admission to Direct Second Year Engineering (2021-22)

The SIES Graduate School of Technology established in 2002 is managed by the South Indian Education Society which has been accorded the South Indian Linguistic Minority status as per the provisions in the Constitution.

10% of the total intake in each branch and against the cancellation/dropouts vacancies would be considered for the Diploma Holders Seats for the Direct Second Year Engineering. The seats will be distributed in the following categories.

1. South Indian Linguistic Minority Category (Tamil)
2. Open category

A. South Indian Linguistics Minority Category (Tamil) and Open Category

Admissions under the linguistic minority (Tamil) category and open category will be done at the Centralized Admission Process (CAP), Directorate of Technical Education/Admission Regulating Authority on merit and as per the guidelines laid down by the Directorate of Technical Education (DTE)/Admission Regulating Authority (ARA), Mumbai. Candidates eligible for admission to the Direct Year Engineering under this category shall satisfy the general eligibility conditions as per the Maharashtra Admission/Fee Act 2015 (Mah. Act No.XXVIII of 2015, the Government of Maharashtra has published the rules on 24.04.2017 and its amendments on 05.06.2018, 04.06.2019 , 09.07.2020 and 18.10.2021 to regulate the admissions to the Professional Undergraduate Technical Courses (Engineering and Technology).

D. Against vacant seats after CAP rounds

Vacancy within the sanctioned intake due to the non-reporting (Minority & Open category in CAP), non-allotment (Minority & open category in CAP) and cancellations, if any (under any category), will be filled as per the ARA/DTE guidelines 2021-22.

Percentage of seats available under CAP/Institute/Minority/All India Quota is decided by the Directorate of Technical Education/ Admission Regulating Authority, Mumbai. The exact distribution of seats available under the above mentioned categories shall be notified by the Directorate of Technical Education/Admission Regulating Authority, Mumbai before submission of applications forms. However, it is made expressly clear that if, after issuance of this brochure, any seat(s) and admission (s) allocation difference exists, a separate notification will be made with appropriate details.

General Eligibility Conditions

Candidates will be eligible for admission to the Direct Second Year Engineering Course as per the eligibility conditions listed below (Refer DTE/Govt. GR notification 2021-22 for details)

- (1) Candidate should be an Indian National
- (2) Passed Diploma course in Engineering and Technology with at least 45% marks (40% marks in case of candidates of backward class categories, Economically weaker section and persons with disability belonging to Maharashtra State Only) in appropriate branch of

Engineering and Technology from an All India Council for Technical Education or Central or State Government approved Institution or its equivalent.

Or

Passed B.Sc. Degree from a University grants Commission (UGC) or Association of Indian Universities recognized University with atleast 45% marks (40% in case of candidates of Backward class categories and persons with disability belonging to Maharashtra State Only) and passed HSC or its equivalent examination with Mathematics as a subject:

(3) Passed D.Voc. stream in the same or allied sector(refer schedule III) of CET Cell Information Brochure 2021.

(4) Any other criterion declared from time to time by the appropriate authority as defined under the Act.

Eligible candidates will be required to fill the online application in the institute (for the Vacancies arising out of CAP) and submit the signed application form along with the required documents in the institute office.

The admission will be confirmed by the Institute only after scrutiny of documents and payment of fees as prescribed by the Fee Regulating Authority, Mumbai.

9. Fees: The fee fixed by the Fee Regulating Authority for the academic year 2021-22 is Rs.1,45,000/- .(Rs.1,29,003/- as Tuition Fee and Development Fee Rs.15,997/-).

The total amount of Rs.1,49,740- is to be paid by Demand Draft/Pay order /RTGS drawn on any bank in favor of the Principal, SIES Graduate School of Technology, payable at Nerul, Navi Mumbai or **via internet banking / online payment.**

Payment by Cash or Cheque will not be accepted.

Cancellation of Admission

The cancellation of admission will be as per the rules and regulations laid down by the Directorate of Technical Education/Admission Regulating Authority, Mumbai.

List of self-attested Copies (one each) of Certificates to be attached with the Application.

- i) Passing Certificate of SSC/Std. X Examination.
- ii) Mark sheet at the qualifying examination (Std. XII or equivalent) if applicable
- iii) Diploma Mark sheets of all semesters
- iv) School/College Leaving Certificate from the Institution, which the candidate has passed the qualifying examination.
- v) Domicile Certificate/Nationality Certificate as applicable (Nationality Certificate is mandatory if the student's Nationality is not mentioned in his/her Leaving Certificate).
- vi) Eligibility Certificate from the University of Mumbai - **students needs to apply to the University of Mumbai through the Institute after securing admission.**
- (vii) Migration Certificate from the Board (in case of candidates who have passed the qualifying examination from outside Maharashtra)
- viii) Minority Status declaration as prescribed in the admission brochure (Proforma – O in page No.64) of Admission Regulating Authority/Directorate of Technical Education, Mumbai in case of students belonging to the South Indian Linguistic Minority.

ix) Gap Certificate (in case of a student passing the qualifying examination before 2021). This certificate is to be prepared in a Rs.100/- stamp paper and duly notarized by a notary public.

x) Caste category/ physically handicapped as applicable.(These certificates are applicable to the students those who are securing admission through CAP)

xi) General Physical Fitness certificate from a Registered Medical Practitioner

xiii)Pre-registration form of University of Mumbai via the UoM portal www.mum.digitaluniversity.ac

However, the original documents are to be submitted at the time of securing admission. However at the time of admission all original certificates should be submitted.
