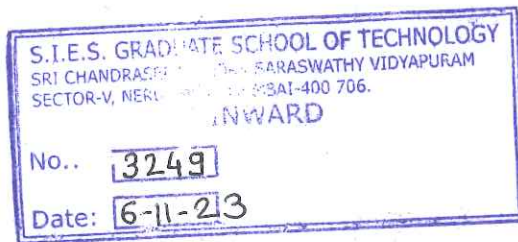
The Authority has received a proposal on 23-02-2023, for Approval of Admission of candidates provisionally admitted in your Institute/College for the Academic Year 2022-23.
